## Marine Corps League Custom License Plate Order Form

This plate is available only through the Marine Corps League and will be assigned only to vehicles registered in the members name. This form will be accepted when accompanied by an accepted method of payment, **DMV Form CP-30**, and with the Consent for Release of Personal Information notarized. Please allow 4-6 weeks for delivery. You must be a member in good standing to be eligible for the Marine Corps League License Plates. If you become delinquent with your Marine Corps League dues, you are no longer entitled to the Marine Corps License plate, at which time the Department of Motor Vehicles will revoke your plates. Once you become a member in good standing again, you will need to reapply and pay the associated fees.

### Vehicle Custom Plate Fees

Initial (assigned)	\$38.75
Annual renewal (assigned)	\$ 0.00
Initial (personalized)	\$70.00
Annual renewal (personalized)	\$31.25

The annual custom plate renewal fee is in addition to your vehicle registration renewal fee. You will be billed for the plates every two years when you renew your registration.

### Motorcycle Custom Plate Fees

Initial (assigned)	\$26.25
Annual renewal (assigned)	\$ 0.00
Initial (personalized)	\$45.00
Annual renewal (personalized)	\$18.75

The annual custom plate renewal fee is in addition to your vehicle registration renewal fee. You will be billed for the plates every year with a fixed expiration date of April 30th.

Standard plates consisting of up to four numbers ranging from 1-9999 followed by the stacked MCL will be assigned by the Department Paymaster. The stacked MCL is not permitted if personalized.

**IF YOUR REGISTRATION EXPIRES IN 60 DAYS OR LESS, YOU MUST RENEW IT BEFORE YOU CAN APPLY FOR THESE PLATES.** This plate is also available with the international symbol of access (ISA) on it for any registrant with a disability who qualifies for such plate. Make check or money order payable to **"Commissioner of Motor Vehicles"**
